PRESIDENT'S REPORT Bill Crum
In addition to his written report:

- Corix, the company that purchased the Adventure Bay water and sewage company, is
 running behind in their billing. They are willing to meet with the community and answer
 concerns about possible unregulated increase in sewage fees. Presently, water rate
 increases have provincial regulations but there are no caps on increases for sewage rates.
- Fire Smart: David Simpson is representing LECA on the city initiative to look at emergency services (fire, flooding, etc.) along with Jim Dubois, Dave Johnston, Michael Arding, Travis Szepesi, Al Rozek and Bill Crum. The city wants more local involvement on these plans. Work on the committee has been slow and ponderous but progress is being made. Dave reported that the city/police/fire department looks after how emergency issues are responded to but the individual homeowner will often need to look after themselves in case of emergency. (Example: grab and go bags, etc.) Our area is

one of high fire risk. The Fire Smart program has recommendations to reduce fire risks but it is up to the homeowner to self assess the risks and reduce issues. An evacuation plan would be up to either police or fire dept as needed. There is only one road out or to exit via the lake. Discussion: Should a fire break be made between our subdivision and the Indian Reserve to the north of us?

- The City has two trained Fire Smart assessors who will, hopefully, visit our area in June
 to do a community assessment. Two things people can reduce individual home fire risks
 by remove tree limbs to 8 feet up and not using wood shavings ground cover. More ideas
 are available in the Fire Smart brochure. Dave brought copies to distribute.
- Block Watch program: This program has never caught on here although there was some
 interest from the police to get this going a few years ago. Is there interest in pursuing this
 program?
